High Point and Reserve High Point Awarded.

5-8 Cross Pole Equitation Over Fences, Working Hunter, Handy Hunter (3 Classes)
9-13 Cross Pole Equitation Over Fences, Working Hunter, Handy Hunter (3 Classes)
14 -17 Cross Pole Equitation Over Fences, Working Hunter, Handy Hunter (3 Classes)

All others will be awarded as follows:

9-13 2' Jump Equitation Over Fences, Working Hunter, Handy Hunter (3 Classes)
14 – 17 2'3" Jump Equitation Over Fences, Working Hunter, Handy Hunter (3 Classes)
